9. The analysis of this Bill is ongoing, and this rebuttal may be advanced at any time by We The People.

### 36. Powers of police to direct closure of places and 4 concerning movement and evacuation

36.1.(1) For the purposes of COVID-19 management while a COVID-19 declaration is in force, a police officer may direct the owner, occupier or the person apparently in charge of any place of business, worship or entertainment in the declaration area to close that place to the public for the period specified in the direction.
