49.33. Further, in **1535**, Henry VIII, brought the '**Poor Laws**' to the table.

- 49.46. That it monetises over and over again.
- 49.47. Indeed, humanity does not know what real life looks like.
- 49.48. It only knows this rat trap of scarcity, poverty, debt and misery.
- 49.49. Thus it is pointless to assume a Court is delivering Law.
- 49.50. It is not.

49.67. It is not a Matter to decide between the two.

49.68. They will always exist, as one does commerce - the Public, and one does not - the Private.

49.69. The critical determining factor of reality is: **who has jurisdiction over the public side?**

49.70. To date, it has not been you.

49.71. But it is now YOU.

49.72. If you are aware of this quantum paradigm shift; as we change Ages from Pisces to Aquarius.

49.73. From Guardianship to Humanitarianism.

49.74. From chattel to Executor and Beneficiary

49.75. From Board of the Guardians, to Trustee, **if found to be trustworthy.**

49.76. As remedy; is the awareness of Humanity that it had failed to differentiate between the PUBLIC, and the PRIVATE, and thus gets drawn into arguing with the Guardianship, about rights, and thus is deemed to be in further standards of incompetence.

49.79. It is how one might access their inherent right to resources, which were inside the private Express Trust of Unum Sanctum. Now terminated, but still in Trust. Will always be in Trust.

49.80. The key question is: who is the **Executor**?

49.81. That would be **You**.

49.82. It is by administering the private tools of the POSOC, by changing jurisdiction,

49.83. These tools were never explained to humanity.

49.84. And thus humanity, the natural **Creditor**, defined by Matthew 5:5

'The Meek Shall Inherit the Earth', becomes the debtor.

49.85. The harvested debt slave within the PMA.

*49.86. The natural **Creditor: humanity**, is now in the process of being restored to its rightful position.*

49.87. There is no distinction, nor separation provided in the **absent rule book** of the POSOC, to clarify that your drivers license is not you. It is just a tool in commerce.

49.88. Your passport is not you, it is just a tool in commerce.

49.89. But the jurisdiction of command has been in the hands of the 'government', who then claim command over you, the sentient Being.

49.90. In becoming the Executor and Beneficiary of your own Trust, the jurisdiction is removed from the government, who becomes the Trustee, **if Trustworthy**, and

is thus, required to follow instructions for the administration of **inherent right to resources**.

49.91. Most importantly, the Blrth Certificate is a tool in commerce.

49.92. It is a receipt for the right of use of your inherent resources, by the ruling hand, without disclosing any details of this contract to you.

49.93. The Birth certificate was launched 1 July 1837, and replaced the settlement certificate.

49.94. It serves as a receipt as part of the Leibor Code 1863, that was developed by Franz Leiber, upon the request of President Lincoln, who required the Laws of War to be written and required access to resources.

49.95. Thus, we continue to be in a state of war, until the alleged debtor stands up and resumes the rightful position as **Creditor**.

49.96. Thus ending this false paradigm of scarcity.

49.97. We can address all matters from a position of **Jurisdiction**.

49.98. **We as humanity; clearly assert Superior Jurisdiction and address the contents of the Emergency Management Amendment (Temporary COVID-19 Provisions) Bill 2022 in the following way:**
