10. As the first deadline of 12pm 30.9.2022 expired, without communication being made, a second date of 4.10.22, 12pm was offered, so that matters may be advanced.
11. As the second deadline of 12pm 4.10.2022 expired, without communication being made, a third date of 7.10.22, 12pm was offered, so that matters may be advanced.
12. As at 1.30pm 7.10.2022, the third offer has also failed to achieve any communication from the public service Office of the Police Commissioner.
13. And by the Scarborough Police station, no communications have been received.
14. As this Office is paid from the public purse, and therefore of inferior jurisdiction, to We The People, of Superior Jurisdiction, it is expected that communications would have been forth coming.
15. It is unfortunate that this Office does not deem itself to be accountable to We The People.
