- 9) Each OFFENDER being guilty of unlawful detainment and apprehension of Takara Markwell on the 28th OCTOBER 2021 the above mentioned offenders participated in or were in the line of authority causing **harming** to Takara Markwell by **Kidnapping and Deprivation of her Physical Liberties** including unlawful detainment/apprehension, this **KIDNAPPING** of Takara and holding her **HOSTAGE** against her will initially at **Christies Beach Police Station** then given false information by offenders so that she would comply caused immense harm and damage to Takara’s well being.

- 10) Takara was **unlawfully held under an arrest in a hostage** situation at an undisclosed location in Adelaide for 36 days from 12 noon 28th October 2021 til 12 noon 3rd December 2021 at \$10,000 per hour per offender identified.

- 11) Due to this gross error in judgement and abandonment of Law, Magistrate Adairs Revoked all Orders by 8th December 2021 after Takara Markwell returned to Donna Markwell and we were residing in N.S.W.

- 12) **As per Annexure D Fee Schedule in attached unrebutted Affidavit Ref ACC-21-1795**

- 13) **Incident Event 3.1:** \$10,000 per hour from 12 noon 28th October 2021 til 12 noon 3rd December 2021 totalling - 36 days x 24 hours = 864 hours x \$10,000 =

- 14) **\$8,640,000 per offender** named above.

- 15) This fee of \$10,000 per hour was clearly verbally told to The Department for Child Protection (DCP) Complaints line over the phone on the 29th October 2021 and voice Recorded and numerous times told to DCP in person to the offenders from DCP Noarlunga and in the Unrebutted Affidavit Ref ACC-21-1795.

- 16) **Incident Event 3.3 - \$25,000 per offender** Unlawful demand of personal testimony, interrogation of and forcefully demanding information from Takara Markwell and Donna.

- 17) **Incident Event 3.4 - \$25,000 per offender:** All demands by Offenders towards Takara Markwell and Donna Markwell on the 28th October 2021 were at the threat of gunpoint and the threat of arrest using; for example invasive tactics of blocking Donna Markwell's car in with other Police Cars and Officers forcefully demanded Donna travel with SAPOL in a Police car and demanded Donna to direct SAPOL to Takaras where abouts at threat of Gun point or arrest and under duress,
- 18) SAPOL then forced Takara Markwell and Donna Markwell at the threat of arrest and gunpoint to get into the back of the SAPOL car under duress;

- 19) Both driven to Christies Beach Police Station and were detained there against our will and given falsified information from offenders,
- 20) only to be told at around 12 noon Takara was not to be returned to me her mother and she removed/unlawfully taken away under duress and by using false information and at threat of gunpoint and;
- 21) Takara reported that DCP lied many times, for example; saying she would go back to her mother Donna Markwell if she complied with requests of DCP and they;
- 22) asked many invasive questions including insisting on medical procedures at Flinders Hospital thus also aligning with the following breaches;
- 23) **Incident Event 3.6 - \$25,000 per offender** Invasive techniques SAPOL:
- 24) Overall ongoing Threats of Harm, intimidation and threat of arrest towards both Takara and Donna:
- 25) **Incident Event 3.7 - \$50,000 per offender;** Donna Markwell went to SAPOL to report a crime then became the victim of SAPOL and DCP crimes and their numerous offences and under duress, forced to comply to SAPOL and DCP demands contrary to Takara and Donna's Right to peaceful occupation of our personal space:
- 26) **Incident Event 3.8 - \$100,000 per offender** – Complete Breach of my Legislated and Legally Enshrined Rights by removing Takara with no court order all actions by SAPOL and DCP were fear evoking and caused emotional and psychological harm and duress,

- 27) all their actions of **Intimidation, Kidnapping and hostage holding were completed on hearsay**, declined to listen to reason and evidence that was presented by Takara or Donna Markwell or family and this is was all very distressing for my friend who witnessed this incident:
- 28) **Incident Event 3.9 - \$100,000 per offender**– Takara Markwell a victim of child trafficking perpetrated by **SAPOL and DCP the for profit Corporations**, under duress complete interference with our physical and political liberty and enforcement of their own profiteering agenda;
- 29) **Incident Event 3.10 - \$200,000 per offender** – under duress, with fear tactics, humiliation, and continuous monitoring and tracking of Takara, offenders went on to remove all communications from Takara with her known outside world,
- 30) **See Emergency Press Release** 14 Year Old Girl.
- 31) Under duress Takara’s phone was taken by Officer **ALLYSON WILSON**
- 32) after 17days of zero communications not knowing if Takara was alive, DCP allow a 45 minutes monitored phone call to Her grandparents in NSW, Millie and Lanced Gudgeon and a second call of 30 minutes a week or so latter all very closely monitored this was the only contact Takara had with anyone she knew and trusted,
- 33) on 28th Oct 2021 All communications were immediately Ceased and blocked between Takara and her mother Donna by the offenders for the 36 days until Takara was returned on 3rd December 2022
- 34) **Incident Event 3.5**; damaging Takara Markwell’s New Samsung 10 Note Smart Phone - **phone \$1,400**
- 35) Court attendance Donna Markwell, Mother, representing herself Standing in Superior Jurisdiction;
- 36) 4th November 2021 Youth Court Adelaide and on
- 37) 27th November 2021 with Magistrate Adairs,
- 38) each appearance being a breach of the following;
- 39) **Incident Event 3.10** beach of natural inalienable Rights \$200,000 not acknowledging Superior Jurisdiction.
- 40) Federal Court of Australia Registrar Geoff Segal declined documents lodged 30th May 2022

- 41) Lodgement number 1098468 CP14 and CP15 stating Reason Out of Courts Jurisdiction.
- 42) On Appeal FCA accepted Administrator Decision Judicial Review in front of Justice Cheeseman.
- 43) FCA Matter Heard on 17th August 2022 and Matter upheld and dismissed: the Unlawful decision of the Registrar of the FCA to not allowing my Documents Lodgement number 1098468 CP14 and CP15 relating to the Fee Schedule for Takara Markwell for Compensation was upheld by Justice Cheeseman thus;
- 44) **Breaching Incident Event 3.10 incurring a \$200,000 fee**
- 45) The High Court of Australia Registrar Adam Griffin declined to lodge grievances against this FCA decision on date;
