their own affairs.

6.1.4. When interfacing with any government departments or making use of any of the tools in commerce; clarify jurisdiction by saying:

6.1.4.1. “For the record, I am speaking with you from Crown Jurisdiction, that is to say, I recognise, that I, as Sentient Being, am in Superior Jurisdiction and administering my tools in commerce to achieve desired and required outcomes.

6.1.4.5. And should I be violated in any way, by yourself, or your colleagues, full personal liability and accountability rests with you and or your colleagues.

6.1.4.6. In Law, Corporate Immunity, does not exist and is not a protection for you, should you harm me in any way, in your capacity to perform your duties in exchange for your pay cheque. ’.
