3.3.2. So if it is a 3rd party of hidden hands, simply do not reply to the request for the name and matters cannot commence.

3.4. It is your responsibility to draw a separation between you in Superior Jurisdiction:

4.1. If you do not have one, do not worry. Just use the following quote:

"As evidenced by my feet on the soil, and the breath in my body,

I accept the use of resources and instruct you to do a 'set off' transaction of the debtor accounting, against the Creditor accounting. Please send me a receipt when completed. Thank you. "

7.1. the first 001 is a **matter** with this particular entity.

7.2. The second 001 is a **communication** #1 with this entity.

7.3. For each further communication it will then become 001-002, 001-003

7.4. If you begin a separate matter with the same entity, create a new number sequence eg: 002-001 - Council garbage collection, 002-002, 002-003 etc  
003-001 - Council spraying glyphosate

7.5. If you start a matter with a new entity begin 001-001. Or a number sequence of your own choosing. Be organised.

7.6. Keep outstanding records of your communications.

7.6.1. Always emailing the entity and yourself.

7.6.2. Create a very organised filing system in your computer of one folder per matter.

7.6.3. When you receive a copy of communications, file it.

8. Always quote the reference number provided to you, by the entity you are communicating with.
9. Be mindful you have clearly written the jurisdiction you are conducting business in.
  - 9.1. Failure to state that will imply you are simply the vessel legal title in commerce and subjected to the statutes and legislations of the now defunct tool of Parliament that writes the rules for the bank.
