8. So regardless, we are here. And we need to make strong progress now on the matters discussed.

10. We have passed an Order in the Grand Jury that failure to respond by any government department does now earn the individual a \$5000 damages invoice. Because our time is not free. And writing and being ignored is a time waster to making progress on important matters.

### 10.1. **Terra Australis Grand Jury 16 8.12.2022. Order # 4**

For the individual, in their personal capacity, occupying the Office of any Public Servant role who fails to respond to Crown Executive Orders, the fine is \$5000 in gold and/or silver; and the individual is publicly gazetted for belligerence and slavery.

What say you Jurors ? Unanimous Yes.

11. I have put in a budget to the Treasury/ Reserve Bank of Australia in December, for \$50 000. That's 100 hours at \$500 per hour for a team to go through the Aboriginal Land Trust.
