**12.2.If Busselton Department of Communities** wishes to substantiate their claims before the Magistrate, an inferior jurisdiction, via Lawful Due Process:

by which earned the investigation and dismissal/resignation of CEO Cathy Taylor, upon discovery that 58 children had died since her employment in the role in 2016:

**13.2.**This matter was tabled at \$10 000 per hour, per public servant engaged in the matter for every hour T Markwell was missing. That resulted in a \$77M claim of Harm and Injury for the South Australia Government and the indemnity insurance policies of its employees.

**13.2.1.**However: to date: the Federal Court has claimed to have no jurisdiction over this Department.

**13.2.2.**The High Court refused to hear the claim.

**13.2.3.**The South Australia Financial Authority claimed its 'Statutory Framework' allowed for such conduct to be acceptable and therefore deemed it carried no liability to reward compensation for such conduct.

**13.2.4.**The outstanding amount of \$77M will, at all times remain valid and accountable. This matter is ongoing.

**13.2.5.**Thus the current estimate of cost to the West Australian Government for the conduct of **Busselton Department of Communities** is tabled as follows:
