42. A **corporation** can only deal with **corporations**.
43. **It has no jurisdiction over the Living.**
44. **Maxim of Law:** That which is created, can never be superior to that which created it.
45. Humans, or similar, created Corporations.
46. Corporations are AI's.
47. AI's cannot suddenly be in charge of Humans.
48. The **ALL CAPITALS** name is a tool in commerce. It is a corporation: **RODD-PENNY**.
49. This system unfolds itself upon the People via use of instruments, called chattel papers.
50. Such as the Birth Certificate.
51. And via terms like 'Public' and 'Person'.
52. The People, with breath in them, are not the Public and are not Persons.
  
53. This system fails to identify the **joinder**: that is; there is a commercial you, in **ALL CAPITAL LETTERS**, called a Person - to do commerce.
54. And there is a Living you - in charge of the commercial you and what happens to you and your access to your **Inherent Right to Resources. Called the Executor and Beneficiary.**
55. By **failure to disclose Joinder**, this system falls on its own sword.
56. It is blatantly guilty of manipulating the Master Trust and leaving Humanity in a position of Guardianship, without free will and informed consent of such a position.

58. Humanity is deemed to be the customer of corporations, when we are the Custodian of these Lands, and the greater Mother Earth.
59. Corporations do not just have free reign to appear, and launch their business model upon Humanity, and render us to be the 'customer'. That is slavery. Examples include Jenoptik, Landis +Gyr, Synergy, Water Corp.
60. The global private Legal system assigns definitions that cause confusion, such as 'Person':
  - 60.1. The term "person" is defined in 18 U.S.C. § 2510(6) to mean any individual person as well as natural and legal entities. It specifically includes United States and state agents. According to the legislative history, "(o)nly the governmental units themselves are excluded."
  - 60.2. Why quote US Code? Because this entire system is registered into the State of Delaware in the District of Columbia. A corporate **leach** that has wrapped itself around our planet, bleeding it dry of all resources for the benefit of the few at the expense of the many.
  - 60.3. Maxim of Law: An un-rebutted claim is a claim that stands.
  - 60.4. So let us rebut and clarify that claim.
  - 60.5. It is not possible for the Living: **Crown We The People Of Superior Jurisdiction** to be assigned the same jurisdiction as the dead: the Corporation of Inferior Jurisdiction.
  - 60.6. It serves the Creators of the US Code to code the Living in this way, by trickery.
  - 60.7. But it does not serve the Living to be coded in this way.
  - 60.8. By failure of disclosure of Joinder, the Living are kidnapped from school, Busselton Primary School in this case, and the dumbed down Community who have had no access to such education; are left to ponder 'how is it that kids can be taken on school grounds? Or anywhere?'

96. Upon use of the instruments, often under duress; One allegedly surrenders their Sovereignty and falls under the entrapment of the Statute and Legislations of the privately owned corporation that calls itself the 'Australian Government' and refers to its Statutes and Legislations as Law.

97. Statute and Legislation is **not Law**.

110. Native Title is a business model that favours the Australian Government and the corporate business model, particularly mining.
- 110.1. This is evidenced by the disenfranchised First Nation population.
- 110.2. Some Elders say, "I have been coming to these Native Title meetings for 28 years. Nothing ever happens in our favour. "

121. Terra Australis is the landmass with living, breathing individuals on it.
122. 'Australia' is a fictional framework of commerce that has been installed over the top of Terra Australis. And alleges to be the Landlord. It is not the Landlord. It is a Belligerent Occupier that harvests children. Parliament House: 4 **Harvest** Tce, West Perth 6005.
123. Here you will find the Commonwealth of Australia is stationed offshore.

143. Because First Nation have never ceded their Sovereignty to Colonial administration, ensuring family units are perpetually disrupted, and in trauma, is a tactic to maintain a power structure that is built on force not justice.
144. First Nation Peoples have the foundational voice of resource management on these Lands, and around the world. Thus they are consistently targeted, disenfranchised and disoriented.
145. The heavily weighted incarceration rates of First Nation on Terra Australis by the Private Members Association that calls itself the Australian Government; a franchise arm of a global administration; it is evident an architecture of persecution exists. A slave system.
146. First Nation People are 17 times more likely to be in prison than non-Indigenous Australia.
147. First Nation are 3.2% of the total population of Australia. But 32% of the total prison population. This is a clear business model of racism, based on tactics of entrapment.

**We live inside a privately owned Legal system that calls itself Law.**

**It is not Law.    It is legal fiction.**

148. It positions the **Custodian/Creditor** to be **customer/debtor** of **Inherent Right to Resources**.
149. This is a highly sophisticated, fully functioning, **violent** slave system; centuries old.
150. Educate yourself to stand in **Superior Jurisdiction**.
151. Public Servants are not rulers. But behave like a ruler. They are Public Servants.
152. 'Government' is an inferior jurisdiction because it achieved its position by stealing **Free Will and Informed Consent** by putting Humanity into a Trust of Guardianship. A nice name for slavery. Common Law is Superior Jurisdiction. Upheld by the Common Law Sheriffs.

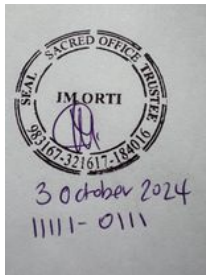
