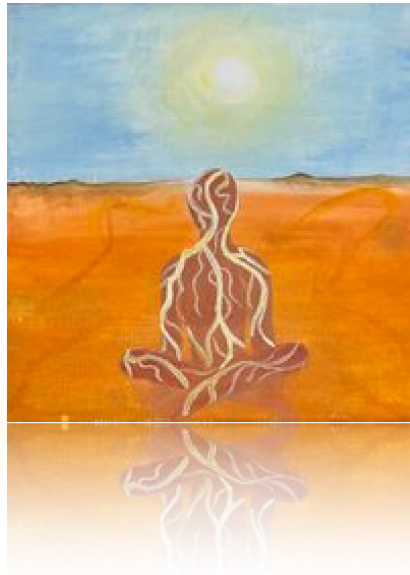

2. After much discussion yesterday afternoon with Senior Wati; Ivan and Kalman, to determine where such a letter may have originated from, it is at best, perhaps derived from discussion regarding Mens business in which case, I and Hilary, would simply need to leave the room. No problems, of course.
3. Ivan and Kalman are unaware of how Graham Campbell would be replacing the types of dialogues I bring to the table, which is simply to define the difference between Lore/Law - Superior Jurisdiction, and Legal - inferior Jurisdiction.
4. The Living - The People - Lore/Law.
 - 4.1. With Breath. Therefore Superior Jurisdiction.
 - 4.2. The Custodians of Mother Earth.
 - 4.3. Law - ancient energetic pathways. The world I work in.
 - 4.4. Management of Land, Air, Water, Spirit.
 - 4.5. Care of Mother Earth: a Sentient Being in her own right.

- 5.4. Positions Humanity as the Debtor/Customer via a privately owned legal system managed through Parliament and writes Statute and Legislation to manage corporations.

6. Elders must have autonomy to plan and create with resources that are rightfully theirs, and witness the trickle on effect throughout community, for not only their own People, but for all People. This is a hugely abundant planet. There is no need for 'industries' such as homelessness and hardship. Nor climate crisis. These are fictional constructs of control. We are well versed in these structures. Remedy would be swift with responsible resource management.

7. This is the long held prophecy of 1000 Golden Years of Peace. There will be no war. How we manage that is to put matters into Right Way.
 - 7.1. I am a Trustee in these matters. Hence my Trustee stamp, and my colleagues stamp; Denise Chadwick.
 - 7.2. We did indeed serve Notice to the Vatican in 2011, via Superior Instruments of Law.
 - 7.3. Pope Benedict XVI was the first Pope to step down in 600 years.
 - 7.4. The Trust was vacated into our care, and a wider team, to ensure correct management of resources was forthcoming.

- 7.7. In this matter, the Executors are the Elders, and Northern Star is the Trustee. In Rule of Law : All Are Equal Before the Law, we must address corporate construct from the seats of those who occupy the Office and hold accountability to that. In this case Hilary and Chad , and others yet to attend, occupy Trustee positions for Northern Star and the equitable distribution of resources.
- 7.8. We speak a highly developed language for the New Age that is upon us. As a Humanity, we are birthing in the New, but traditional, paradigms of equitable resource management.
8. Kalman will follow up with a brief email to clarify that I remain in the same position I was in prior to yesterdays email. That is:
 - 8.1. I advise and assist.
 - 8.2. At no time do I take a position to lead the Elders.
 - 8.3. I do not re-present the Elders as they are wise and competent individuals. I acknowledge their words and wishes and translate them into documents such as these.
 - 8.4. Nor do I issue false hope about timelines when large quantities of resources are in the hands of complex corporate structures. Rather, I caution heavily against extremes of high and low and to walk a steady path of focused intention.
9. I am in daily communication with Elders for years now. I have always worked for free until such time the resources are correctly disbursed. And then by Right Way, my time and service will be graciously remunerated.
10. Thus I clarify where we were up to before the matter of yesterdays email occurred.
 - 10.1. The Elders had requested relief money of \$30 000 each. Bank details available as soon as we have clarity that this is going ahead.

- 10.1.1. Hilary, please advise specifically on these matters and particularly any encumbrances to progress.
- 10.2. Seperate funding is required to attend meetings in person, so a broad discussion can be witnessed. Whilst we appreciate the compartmentalisation of the corporate structure, Mother Earth is a Living Being with her systems interconnected. Thus discussions are vast and stretch through songlines that only the right Elders can speak about as they have been carrying the knowledge for thousands of years.
- 10.3. Chad can you please email Community initiatives as soon as possible so we can see what has been attended to up until this point.
- 10.4. Please do include monies assigned to any First Nation groups/Native Titles, as we discussed that these figures were not showing up in the end of financial year statements.
- 10.5. Yesterday, quite separately and independently, Ivan, Kalman and Uncle Otto each requested a vehicle. Can this be organised please for immediate dispatch?
 - 10.5.1. In particular, Ivan is anxious to attend his sisters funeral and assist with appropriate ceremonial traditions. Thank you.
- 10.6. While this might seem obnoxious for my blatant requests, we must address matters in the following way: it would be fair to say that as little as 51% of shares belong to the Elders/Custodians, for use of Custodial Lands for profit, by corporation, but all profits are in the hands of the Guardianship/corporations. Large banks specifically.
- 10.7. This is the time of the Terms and Conditions issued by the People, for the People.
- 10.8. The Elders are offering their first round of Terms and Conditions to begin correcting the records. Thus please acknowledge these simple opening requests with respect and in a timely manner so that we may proceed to further face to face meetings.
- 10.9. Kalman has identified a vehicle he is interested in.
