### **The Claims Against the Defendants**

The claims are:

1. Full Disclosure Denied
2. Personage - Disregarding Age of Majority Declaration - Fraud
3. Non Disclosure of Valuable Consideration
4. Failure to Acknowledge Private Settlement Agreement
5. Disregarding Bill of Exchange
6. Unwelcome and Unlawful Trespass
7. Extortion - Demanding Property with Intent to Steal - Mortgage over Property – Threat of Enforcement Action/Theft
8. Extortion - Profiteering Through Deception – Banking Fraud
9. Deception – Securitisation of Financial Instrument

### The Verdict and Remedy of the Court

#### 1. Let it be known

- 1.1 to all people of Western Australia: a commercial zoned area of the land mass known as Terra Australis (AKA Australia)\*,
- 1.2 and Australia: a commercial zoned area of the land mass known as Terra Australis,
- 1.3 and to the greater world,
- 1.4 that a jury of twelve competent, capable and upstanding men and women of Perth in Western Australia\* have carefully considered extensive evidence presented by The Claimants

#### 2. Let it be known

- 2.2 that The Defendants have failed to present themselves to this court
- 2.3 the court considers the Defendants as 'in absentia', therefore freely choosing not to take the opportunity to rebut the evidence provided
- 2.4 all Claims were considered individually by the Jury

#### 3. Findings

- 3.1 Mr Mike Warren - **guilty on all twelve claims**
- 3.2 Tony - **guilty on all twelve claims**
- 3.3 Mellissa - **guilty on all twelve claims**
- 3.4 Isabel - **guilty on all twelve claims**

3.5 Gary McNamara - not guilty on claims 1, 2, 3 and 4.

Guilty on claims 5, 6, 7, 8, 9, 10, 11, and 12

#### 4. Remedy

4.1 Mr Mike Warren - financial penalty \$285,000,000.00 plus 290 years jail

4.2 Tony - financial penalty \$142,500,000.00 plus 145 years jail

4.3 Mellissa - financial penalty \$132,500,000.00 plus 145 years jail

4.4 Isabel - financial penalty \$285,000,000.00 plus 290 years jail

4.5 Gary McNamara - financial penalty \$70,000,000.00 plus 60 years jail

4.1 See Annexure 1

#### 5. Interim Remedy

5.1 This interim remedy as determined by the Jury, until We The People have access to our facilities and infrastructure returned:

5.2 All Defendants are to be dismissed as Trustees forever

5.3 A Caveat is to be placed on all assets of all the Defendants

5.4 All assets of all Defendants are to be sold

5.5. All Passports are to be revoked

5.6 All Defendants must immediately resign from employment

5.6.1 and may not be re-employed without permission  
from this Common Law Court

5.7 All Defendants are to be blacklisted for being incompetent Trustees

5.8 Defendants must access their Public Liability Insurance Policies to pay the financial penalties ordered by the jury
