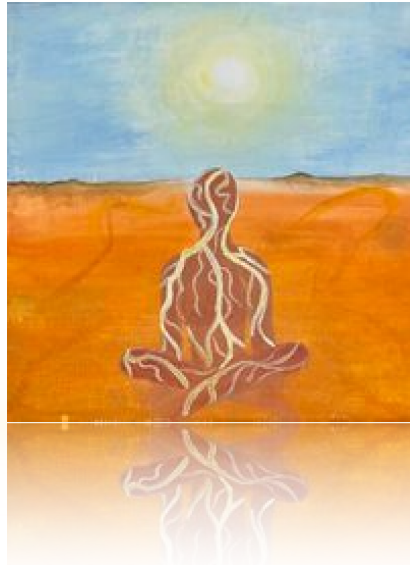

- 3.3. The People have binding to Maxim of Law.
- 3.4. Maxim of Law protects the People from Treason, Fraud and Slavery by following Lawful Due Process.
- 3.5. Maxim of Law is used to measure all actions against Lawful Due Process.
- 3.6. All actions failing Lawful Due Process are deemed **Null and Void**.

4. The Writ of Summons filed in the Action on 11 October 2024.

5. Status of the Action

- 5.1. Reference to your point 1
- 5.2. The Writ of Summons in the Action on 11 November 2024 has no standing in Law. The Supreme Court is a privately owned legal fiction. It is not a system of Law. Despite referring to itself as Law.
- 5.3. It has no jurisdiction in alleged claims of Land.
- 5.4. No Lawful Transfer of Title to the corporate Crown exists.
- 5.5. **Please immediately produce it, if you have it.**
- 5.6. **By 12pm AWST, Friday 13th 2024**
- 5.7. 'Failing to file a Memorandum of Appearance' : in a court of inferior Jurisdiction - ie The Supreme Court of Western Australia has a Vote of No Confidence against it.
- 5.8. It repeatedly fails Lawful Due Process.
- 5.9. It is an incompetent and illegitimate Court.
- 5.10. Keystart may file its claim to be Landlord before a Common Law Court and be heard before a full jury. It should have the historical paperwork available to support that claim.

6. Keystart should produce its 'Papers Please' - to verify it has an authenticated claim over the Land.
 - 6.1. It does not have an authenticated claim.
 - 6.2. And cannot produce any paperwork to substantiate an authenticated claim.
 - 6.3. Issuing a Form 36A is an act of Treason, Fraud and Slavery.
 - 6.4. All Keystart employees will be 100% liable and accountable for their participation in such actions.
 - 6.5. As will Brian Smith of Dentons, who consistently acts in matters of Land and property seizure, knowing there is no Lawful, historical process to be found to substantiate such claims.
 - 6.6. **Maxim of Law: All are accountable for their actions.**
7. **Your Point 2:**
 - 7.1. Intent to pursue Default Judgement
 - 7.2. All parties will be in 100% personal liability and accountability for failure of Lawful Due Process in pursuit of treason, fraud and slavery.
 - 7.3. The Supreme Court is incompetent and is a Court of banking, not Law.

10. Your point 4. Sheriffs.

- 10.1. The corporate Sheriffs are part of the **enclosure** of this fictional system referring to itself as Law.
- 10.2. Eviction is an act of Treason, Fraud and Slavery.

- 11.5.2. They display no knowledge of Law and were quoting Acts at the Common Law Sheriffs as if it were Law.
- 11.5.3. It is not Law and has no binding upon the Living.
- 11.5.4. Acts are inferior jurisdiction when dealing with Common Law Sheriffs.
- 11.5.5. Police (policy enforcers of the private offshore corporations) allege to have powers they do not have.
- 11.5.6. These individuals became complicit in Treason, Fraud and Slavery by protecting the Dentons office, and actions within the Dentons Office, whilst also displaying clear evidence that they have no idea what they are involved in, do not know the difference between Law and Legal, and yet are positioned to be 100% personally liable and accountable for their actions, by their employer.
