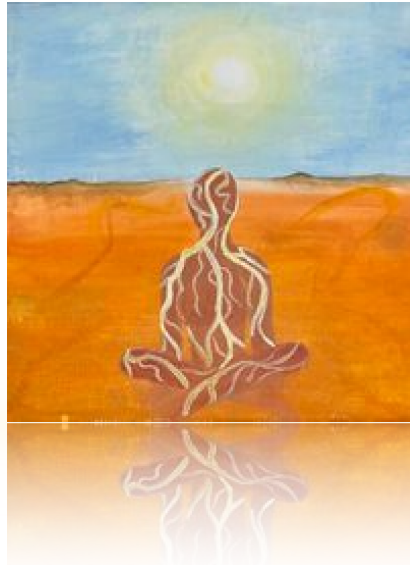

Voice of the First Nation Elders of Terra Australis

1. 28 November 2024.
2. Document TT8801-2024-011-011
3. **The Lore of LAWS: The Custodianship of Land, Air, Water and Spirit by the Sentient Living Beings.**
4. **This document is on the record**, for now and forever more; of **Superior Claim** above all other Claims
 - 4.1. and can never be superseded by local alleged authority, or those from other Lands.
 - 4.2. Nor by the 'corporate language' of Statute and Legislation by a corporate global governance, to which the Sovereignty of the Living has never been ceded.
 - 4.3. Nor by the continuation of the capture of Humanity by **failure of Lawful Due Process**, that is the failure to acquire **Free Will** and **Informed Consent** to be administered within a privately owned Trust as chattel slave under Guardianship. That being Unum Sanctum 1302: a privately owned Vatican instrument and the continued unfolding of such privately owned instruments, such as Native Title.

5. **By Our Free Will and Informed Consent; the Guardianship is terminated.**
6. **Humanity is free from all such instruments.**
7. **Crown, We The People of Superior Jurisdiction**, and particularly the **First Nation Elders** of these Lands, known as **Terra Australis** do hereby speak our **Word** and **Claim**;
 - 7.1. that we do not recognise the Australian Government as an Authority, on these Lands.
 - 7.2. Or as the Landlord on these Lands.
 - 7.3. The Australian Government is not the Lessor of these Lands, and **Crown, We The People of Superior Jurisdiction** the lessee.
 - 7.4. The Lessee is the Australian Government, and the Lessor is the Living Elders.
 - 7.5. The management of Land Use is hereby restored to the Living Elders by Right Order and Right Way.
 - 7.6. By Order of the Elders: The Australian Government is hereby rendered to be an administration system only, paid for by **Crown, We The People of Superior Jurisdiction**, via the monetisation of the Birth Certificate.
8. All Landlord matters, and Authority matters, remain with the **First Nation Elders**.
9. **Crown, We The People of Superior Jurisdiction**: the Living, do recognise the Australian Government, as an offshore, **privately owned corporation** that has laid its commercial construct over these Lands, as an alleged authority, and harvests resources for its own profit and gain. For the benefit of the few, at the expense of the many.

10.2. **"Australia"** means the Commonwealth of Australia and, when used in a geographical sense, includes Norfolk Island, the Territory of Christmas Island and the Territory of Cocos (Keeling) Islands, but does not include any other external Territory.

11. **Crown, We The People of Superior Jurisdiction**, and particularly the **First Nation Elders** of these Lands, known as **Terra Australis** do recognise the Australian Government to be doing commerce on these Lands **without** Treaty, **without** Blessing, **without** Invitation and **without** Bill of Sale for Land Use and Resource Harvest.
12. And by **plausible deniability** does fail to recognise the **Bills of Exchange Act of 1909**, thus positioning Humanity to be a perpetual debt slave, paying for our own resources. This is **Crimes Against Humanity**.

14. The Australian Government fails equitable distribution of Resources to the Custodian/Creditors of these Lands.
15. And does maintain that position by extreme acts of violence against Humanity including assault, kidnap, hostage, Land theft, incarceration and exacerbation of trivial matters that entangle life for years, within its privately owned judicial system that is, **by wilful intent to deceive Humanity**, called 'Law'.
16. Such 'Law' is corporate Statute and Legislation and is not Law; but a privately owned legal system, designed to protect its own monopoly game. All industry is monopolised by the same alleged authority, despite a monopoly being a strictly forbidden business model, based in **slavery**, due to the eradication of the supply and demand mechanism.
17. **Crown, We The People of Superior Jurisdiction** have no binding to such claim of 'Law'.
18. And have only binding to **Lore of LAWS**, that being Maxim of Law, that being Superior Jurisdiction, that being the Laws of Nature, of which the Living are a part of and are free to use to protect ourselves from tyranny.
19. By Order of the Elders: The Australian Government is hereby rendered to be an administration system only, paid for by **Crown, We The People of Superior Jurisdiction**, via the monetisation of the Birth Certificate, in which the Terms and Conditions for Humanity, were silenced via the function the Guardianship.
20. These are the Terms and Conditions for commerce on these Lands.
21. All corporations are held to account for **'Papers Please'**, and should refer their own matters and alleged authority to conduct commerce on these Lands; back to the Australian Government that has by wilful intent presented itself as the Landlord, as the Authority, and having the right to sell access to own and harvest resources, when itself has no historical documents to support how it would have ever acquired that position.
