## National Sheriff Report for the year 2024

Terra Australis Grand Jury as National Assembly

- 14.1.Due to the sudden increase in the number of Sheriffs around the Country14.2.And the fact that they are answerable to an Assembly14.3.And the acknowledgement that Assemblies are yet to form for all Sheriffs
- 14.4.It is determined that the Terra Australis Grand Jury will serve as a National Assembly, for Sheriffs who are yet to have an Assembly form in their area.
- 14.5. This is rather than SPAWA; The Sovereign Peoples Assembly of Western Australia in an effort to divest some of the responsibilities of SPAWA, and in acknowledgement that the Terra Australia Grand Jury's have a National representation of folks; unlike SPAWA.
- 14.6. Thus a broader cross section of the Nation can weigh in on Sheriff Code of Conduct matters, until Assembly's form and can take over that role themselves, whilst always conferring back to the National Sheriff meetings, every second Saturday.

## 14.8. Unanimous Yes

- 1. We have inducted 21 national sheriffs and had
- 2 of those resign although we can clarify that was specifically because of scare generated by the psychiatric industry snatching a Sheriff and incarcerating him. This was fuelled be ill published content in the Newscorp

Advertiser. This is a culture of publishing to incite unrest in the face of Law. We are holding accountability to that.

- 3. 3 are from WA and are members of SPAWA
- 4. Prior to this GJ we inducted 24 sheriffs nationally
- 5. with 7 of those from SPAWA,
- 6. all of them still with us
- 7. In April 2024 we began to develop the online induction program which took a decent amount of time and was utilised to induct the last 7 sheriffs.
- 8. Feed back has been good with only one individual who has had multiple tech issues, stemming from user error. He is not included in the statistics as he is still progressing through.
- 9. Fortunately we have a very patient IT who is guiding him along the way.
- 10. We went through most of the year with fortnightly meetings on a Saturday, at midday Perth time. This was not a very convenient time for many Sheriffs so we moved to monthly meeting on the first Monday of the month.
- 11.Unfortunately that doesn't suit everyone either but given the time differences and acknowledging that everyone has various other commitments it is accepted that we will not get a day and time that suits everyone.
- 12.It was a fairly quiet year for field work compared to 2023. However, we acknowledge we now have a vast body of case material in many different areas, contributing to a rich voice of knowledge around the injustices, of the system that it likes to call Justice.
- **13**.Hereon in, and in 2025 we will be holding fresh eyes, and systems of accountability to that.
- 14.In Perth we conducted a few major excursions out in to the community.

- 15.In WA: A group of sheriffs travelled south to the small town of Narrogin to attend the local court with 2 sheriff as witnesses and several attending in the gallery.
- **16.**We served documents in the South West town of Busselton to the DCP, Primary school, police station and library.
- 17. The Policy writers at the Energy Regulatory Authority in Perth City were also served, as they write Policy to position Humanity as the debtor, when we are the Creditor.
- 18.Perth Sheriffs have also conducted several community walkabouts to raise awareness of Common Law Sheriffs in the landscape. This has been warmly received with much curiosity.
- 19. Sheriff Dale in QLD was busy serving documents to corporate entities and Im happy to report that he has another Sheriff in his area now with yet another due to be inducted as soon as possible.
- 20.SA has worked really hard on a major case involving the psychiatric industry and the violent harm and injury it has perpetrated on one of our Common Law Sheriffs.
- 21. That case highlights a multitude of blatant trespass upon the Sovereign.
- 22. Sheriff in NSW have also been busy in community events attending Forest of the Fallen displays.
- 23. Sheriffs in the Hills District NSW are working on building community towards establishing an assembly in their area. Feed back is there is relief in the community to see Common Law Sheriffs.
- 24. A total 52 Sheriff Reports were generated.

- 25.On behalf of the People of Terra Australis and initially from the WA Common Law sheriffs Office and then the National sheriffs Office we have issued 86 penalty notices with a value of \$9,678,000,00.
- 26. These were followed up with Overdue notices and then Default notices and the next step is Caveat Notices.
- 27.Behind the scenes the admin team have been busy setting up systems with the view to streamlining the work and making it easier for the People to manage their own matters. And to prevent bottlenecks with so many matters flowing in all the time.
- 28.We have a revamped the Reporting Form on the Sheriff website for People to report someone to the Common Law sheriffs if they have suffered Harm or Injury by Failure of Lawful Due Process at the hands of the Corporations.
- 29. As we move into 2025, we aim of have structured many new systems to assist Community.
- 30.In 2025 we aim to steadily build the national sheriff team and the national peacekeeper team, and with the hard work of this year out of the way, have more time to get amongst the people and let them know We are here.
