21. This is an easy, quick and visual reference point as to what happens in each jurisdiction of Lawful and Legal.

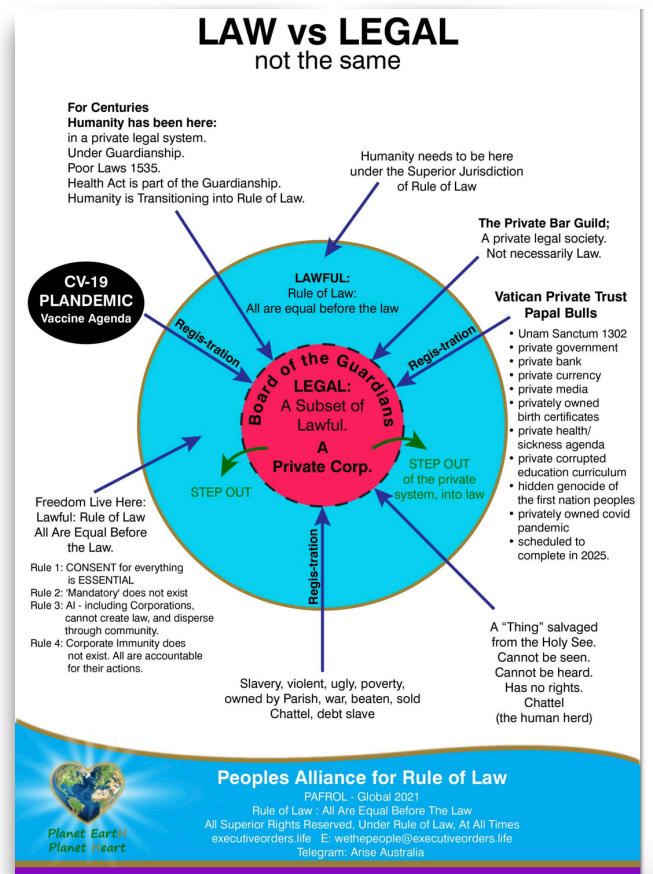
22. Legal: the pink circle is inside the blue circle because it is a subset of Law.

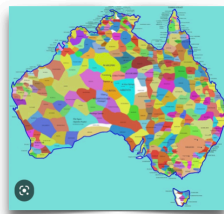
