### Voice of First Nation

1. Greetings Australian Government.
2. The **Voice of First Nation** is alive and well.
3. We thank you for your **offer** to have a 'Voice in Parliament'.
4. However; what is required as **Lore/Lawful Due Process**, is that the **private legal system** that refers to itself as the 'Australian Government' - a corporate, commercial enterprise; **requires an invitation from First Nation**: the True and Original Custodians of these lands, who have never ceded their sovereignty to these lands; to offer it a Voice on these lands, **Terra Australis**.
5. Therefore, the invitation of a Voice in Parliament is **secondary** to the Australian Government **first** receiving an invitation from **First Nation** to continue to conduct commerce on these lands.
6. Thus, the claim of Superior Jurisdiction of We the People is hereby made. And all matters will fall into place accordingly.
7. Therefore, we recognise the 'Native Title Act' to be of *inferior jurisdiction* on these lands, to the **Original Voice of First Nation: the True Custodians of these lands: Terra Australis**; and what will be permitted, or not, from this day forward.

8. Thus recognising the Australian Government to be an **administrative body** upon these lands, and not the lands themselves. And has arrived, 1788, without invitation, nor Lore/Lawful Due Process, nor with Treaty in place, nor evidence of Bill of Sale.
9. Thus the responsible **Use of Resources**, and the determination of the equitable distribution of returns from the use of resources remains with **First Nations and We The People of Terra Australis as a collective**, and not with an administrative body, and its arms of function such as the Native Title Act.
10. **No further matters pertaining to Native Title may proceed without Elders of First Nation agreeing to it.**
11. It is not sufficient that some individuals corporatise themselves, and allege to have jurisdiction for First Nation, and for sweeping decisions of Use of Resources, coupled with a failure in transparency of distribution of return on investment of such Use.
12. **That time is complete now.**
13. Whilst matters may be heard and considered, no matters, under the guise of Native Title may be signed off on until the correct process with Elders, has been seen to. And adhered to.
14. Any matters failing this process will be deemed Null and Void.
15. Any business arising from such processes will be deemed Null and Void with all loss falling on the parties participating in contracts that have failed **Lore/Lawful Due Process.**
16. We trust you appreciate the importance of **Lore/Lawful Due Process.**
17. We thank you in advance for your recognition of what has always been an inevitable occurrence, and **We The People of Superior Jurisdiction** welcome
