This claim is made against the perpetrators of fraud, harm and slavery, who failed to rebut, claims and statement, by way of a Notice of Action, a Commercial Lien, For Harm & Fraud, against the living man, :Denis-Peter: done Overt and Public; as these crimes must never be hidden, they are to be made public, due to their very nature, of violating the Lore/Law, of God, "the Creator" and Rule of Lore/Law, to which every living soul in all jurisdictions of Land-Air and Water, who are answerable; as no one is immune, fraud, harm and slavery are not victimless crimes and as such the perpetrator/s must face justice; for we are all equal before the Lore/Law; and as there are many crimes, that have-





been committed, against I, the man, known as :Denis-Peter: either knowingly with intent, or by association, where those in a position, to take action to stop such crimes, and make a honourable judgment for the good of the people; having been made aware, but choose to ignore the plight of the people, that are, being fraudulently dealt with, harmed, and claimed as property through a tort in conversion of the living name, to that of a slave, forced to stand as surety, to allow the breaching of the master trust, "usurping" by others, being theft; and

By taking that position those that go along with the crimes being committed, are just as guilty as the perpetrators, for it is a crime to conceal a crime, to which an offender can receive up to two years in prison; and

Whereas fraud and harm, being done knowingly becomes unforgivable offences, as is slavery, which can include up to 25 years imprisonment, and the penalty for debt bondage includes up to seven years imprisonment; and

The claim of a tort in conversion of the living name against I, the man, is debt bondage, and by not correcting the records to stop the crime, is forced slavery, and to deprive one of an essential power supply, to force compliance with a crime, is harm and slavery being done knowingly with intent; and

Of which; has all been agreed to, by those named below, through tacit agreement, under God's Lore/Law and Rule of Law, in their acting roles, be it for, ERGON ENERGY QUEENSLAND PTY LTD, or ERGON ENERGY RETAIL, or THE QUEENSLAND GOVERNMENT, or Government Agencies or Government owned Corporations; they also do it, for and on behalf of, ERGON ENERGY QUEENSLAND PTY LTD and ERGON ENERGY RETAIL, and THE QUEENSLAND GOVERNMENT, and Queensland Government Agencies and Queensland Government owned Corporations; by the very fact of the failure to rebut the claims and statements made, in the Declaration and Statement of Truth and Fact; Regarding harm and fraud against the living man; by way of an "Affidavit" by I, the man, known as :Denis-Peter: a sui juris; and
