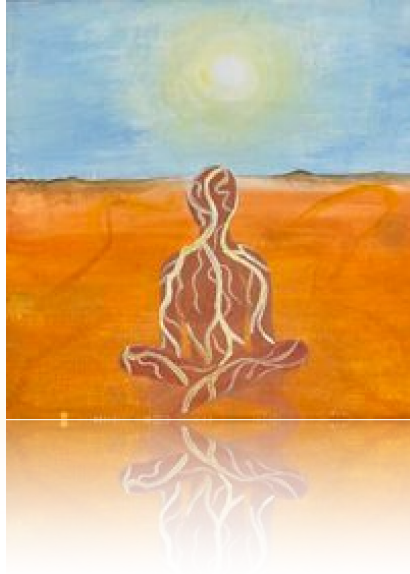

5.1.13. Again, the Trust account is opened for every day the living body of Gerard Ashwin occupies a jail cell.

5.1.16. This matter is deemed **Null and Void** and Gerard Ashwin is free to be released having served a jail sentence from November 25 2022, with 2 years of hearings prior to that.

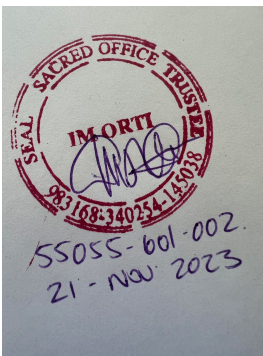
