Note: It is important to read and comprehend this Notice in full, as it will be given in evidence.


Under Law: all individuals are personally liable in both their acting roles and private capacity for the effect of actions or inactions they take, cause or allow, to which they can be held fully liable.

Dishonour: and Remedy.

- (1) Direct or send to I, the man, the secure party, any communication not correctly addressed to :Denis-Peter: sui juris, or the Secure Party; but is addressed to the Created Named Trust, legal fiction, persona, or the ens legis juristic person, ... which may be ignored or returned to sender without a contract being established or dishonour caused; though may be opened to ascertain the author and claim being made, however the opening of the communication does not confirm acceptance of any claim/s, be they genuine or fraudulent, as no consent to contract or joinder is given, furthermore, should it be an attempt at identity theft, surety fraud, or violating any of the following clauses, then in conjunction with any other clauses being claimed; For which the following Remedy shall be claimed and due on demand;
Ten Thousand Dollars; Au \$10,000.00, per incident.

- (5) Contact any commercial entity, person, business, local, state or federal government body, department, authority, court, bank, financial organisation, debt collection or reporting agency, police or policy enforcement agency about a matter, that causes or results in any dishonour, injury or damage to I, the man, or my family, of our good name or creditworthiness, or the action violates our privacy; then the following Remedy shall be claimed and due on demand; Two Hundred Thousand Dollars; Au \$200,000.00. and a further Twenty Thousand Dollars per day \$20,000.00. or part there off, till a formal public retraction and a written public apology is made.
- (6) By your action or inaction, cause, influence or otherwise bring about or be a party to the arrest, claimed judgment and seizure of property without trial, detainment, incarceration, physical or mental injury or death of I, the man, or any member of my family, associates or friends; then the following Remedy shall be claimed and due on demand;
- Twenty Thousand Dollars; Au \$20,000.00, per individual so effected for each day or part thereof; and



- (10) Send, allow or cause to be sent any adverse report, notice or information concerning any aspect of the living man 's life, financial situation or property, to any person, business, local, state or federal government department, authority, agency or official, court officer, lawyer,. police, commercial entity, bank officer or financial, debt collection or credit reporting agency, then the following Remedy shall be claimed and due on demand;
Eighty Thousand Dollars; Au \$80,000.00, per incident;
- (11) Deny or otherwise fail to Accept For Value I, the man's, bond or other remedy, to off set claim by the creator of the named trust, then the following Remedy shall be claimed and due on demand;
Twenty Thousand Dollars; Au \$20,000.00, per incident.
