That also contained a second offer that would allowed for a further seven days should you require it, to rebut “any of the points under oath to be removed from the; “Declaration and Statement of Truth and Fact; Regarding harm and fraud against the living man on the 10th of March 2023, RPP44 63700 51001 39727 53609, delivered 13th March 2023 ... Prior to that which stands as unrebutted, and now to be claimed as the truth in law, in all jurisdictions, of Land-Air-Water, in perpetuity; and

Therefore: it can never be claimed; I, the man, with the unincorporated name :Denis-Peter:, sui juris, the sole (soul) beneficial owner, standing as the Executor and Beneficiary of the, DENIS PETER RAWLINSON Trust, acted dishonourably; as the prior notice did carry enough warnings, in regards to any Acquiescence, (silence) that under law, would be your total Agreement, by choosing to standing in Dishonour; and

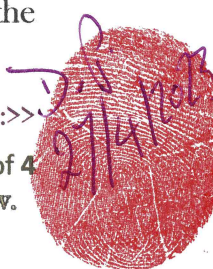
